

Annual report for 2022 from the implementation of the Regional Operational Programme for Warmińsko-Mazurskie Voivodship 2014–2020



Announced **576** calls, worth over **2.88 billion euro**



5 202 contracts were signed for the amount of EU funding over **1.66 billion euro**, which represents **95.1%** of the Programme budget



Beneficiaries were paid over **1.28 billion euro** of EU funds, which represents **73 %** of the Programme budget



The European Commission has approved over **1.44 billion euro** funds, which represents **82.2 %** of the Programme budget




RURAL AREAS




- 20.1 % of the value of all signed co-financing agreements concerns funds used in rural areas;
- This constitutes 19.1% of the entire allocation of the ROP WiM 2014-2020;
- By the end of December 2022, 15.2% of the ROP WiM 2014-2020 allocation had already been spent in rural areas.

- In 2022, MA ROP WiM 2014-2020 managed to achieve a large number of objectives, more than was planned, related to the certification of funds defined within the framework of the so-called "n+3 rule";
- by the end of 2022, it was necessary to certify over 998 million euro of the EU contribution,
- over 1.4 billion euro was performed, which is approx. 144% of the commitment resulting from the "n+3" rule.

IMPLEMENTATION OF THE „N+3 RULE” IN 2022




PERFORMANCE FRAMEWORK




- 19 indicators of performance framework (58% of all the indicators) have already reached the target value at the end of 2023;
- In the case of 6 indicators the purpose was achieved on the level 80%-100% (18% of all the indicators);
- In the case of 5 indicators the purpose was achieved on the level 60%-80% (15% of all of them);
- for 3 indicators the purpose was achieved at a level lower than 60% (9% of all the indicators).



In 2022, we continued to publish **press inserts (4 editorial pages each)** entitled "Funds for changes" in Gazeta Olsztyńska and Dziennik Elbląski. 8 editions of the insert are behind us, the last one was released on April 29, 2022.
The average circulation of the Friday editions of the newspaper, when the inserts were published, amounted to over **13 000 copies**.

In 2022, **5 regional televisions** (TVP3 Olsztyn, Telewizja Olsztyn, Telewizja MAZURY, TRUSO and KTK in Kętrzyn) broadcast mini-reports on ROP projects.
 In total, the reports were broadcast over **1 000 times**.

In 2022, we organized **12 trainings** for beneficiaries. **512 people** took advantage of the offer.
 The training was carried out **online**. After the training, the videos were posted on our YouTube channel.
